Course Purpose and Content

The course aims to provide a set of advanced insights into the field of innovation management spanning from foundational themes to the most recent developments. The course is informed by a strategy perspective.

The competitiveness of firms, economic growth and societal welfare in general depend on the ability to introduce innovative products, processes and services. Interest in the management of innovation has traditionally centered on firm-internal aspects of processes such as, for instance, how collaboration and interaction among specialized professionals take place in the creation of innovation; how to deal with unavoidable uncertainty involved; and the path dependency in skills and resources. In recent years, there has been a surge in interest among scholars and practitioners in methods that allow the firm systematically to source its inputs externally. Innovation that originates from sources external to the firm has emerged as an important phenomenon and has been associated with labels such as open innovation, user innovation, crowd sourcing, and open source. These trends have also given rise to novel and so far immature research agendas that promise to enhance our understanding of the processes and sources of innovation in the years to come.
